Incident: MHJD-01 enter the Needle Ways below Echo Falls, finding a crowded shanty town setup among the ruins. While attempting to secure and lock down the area, members of the Lords of Cinder ambushed the officers. In the ensuing firefight there were minor civilian casualties. PTSD however is highly likely for more civilians in the area. The Lords of Cinder dispersed after the ambush back into the shadows and the Needle Ways were locked down. Only minor injuries sustained.

Detail of Event:

*Upon entering the Needle Ways on a sweep and secure mission, the judges were quickly bogged down by the large amount of squatter's setup in the ruins. Not long after arriving and beginning their sweep, shots would ring out and send the judges scrambling for cover as the Lords of Cinder began their ambush (**CRIME: Code02/Section01 – Assault on a Judge. SENTENCE: 10 years in cubes upon capture**). The locals, realizing they were in danger began running and screaming. Some even opened fire on both the judges and Lords of Cinder gangers, not knowing who was firing near them.*

*Judge Dredd was hit and knocked down, but not wounded (**CRIME: Code02/Section01 – Assault on a Judge. SENTENCE: 10 years in cubes upon capture**).* The civilians beside the shooter turned and fired at him before taking off into the ruins themselves. Judge Ramos returned fire to keep the initial shooter pinned and other gangers near him.*

*A young looking juve came flying over the central ruins on a hoverboard trying to catch Judge Solomon unaware. However, before he could fire off his hand flamer, Solomon fired his bolter in self-defense and seriously injuring the young juve.***

*The leader of the Lords of Cinder fired an extremely lethal lascannon round in retaliation at Solomon but by sheer luck, it hit the wall right beside him and left him unscathed (**CRIME: Code02/Section01 – Assault on a Judge. SENTENCE: 10 years in cubes upon capture**).*

*While both Dredd and Ramos came under further fire*** (**CRIME: Code02/Section01 – Assault on a Judge. SENTENCE: 10 years in cubes upon capture**), keeping them pinned, the disciplined return shots by the other judges caused a few more serious wounds on the Lords of Cinder. Soon after, the las fire from the ambushers trailed off and they retreated into the shadows. The panicked screams of the civilians were all that could be heard once all sounds of battle had ceased.*



Summary:

The Needle Ways were fully swept for any further gangers and then shut down for good. No injuries sustained by the members of MHJD-01. 1 enemy ganger confirmed seriously injured but was taken away by his gang before we could secure them.
